



Electronic billing for cross-border transactions

Exchange System tool "ES"

The preparation and submission of XML invoices relating to foreign entities through the Exchange System (SdI) will allow simplification of some administrative processes.

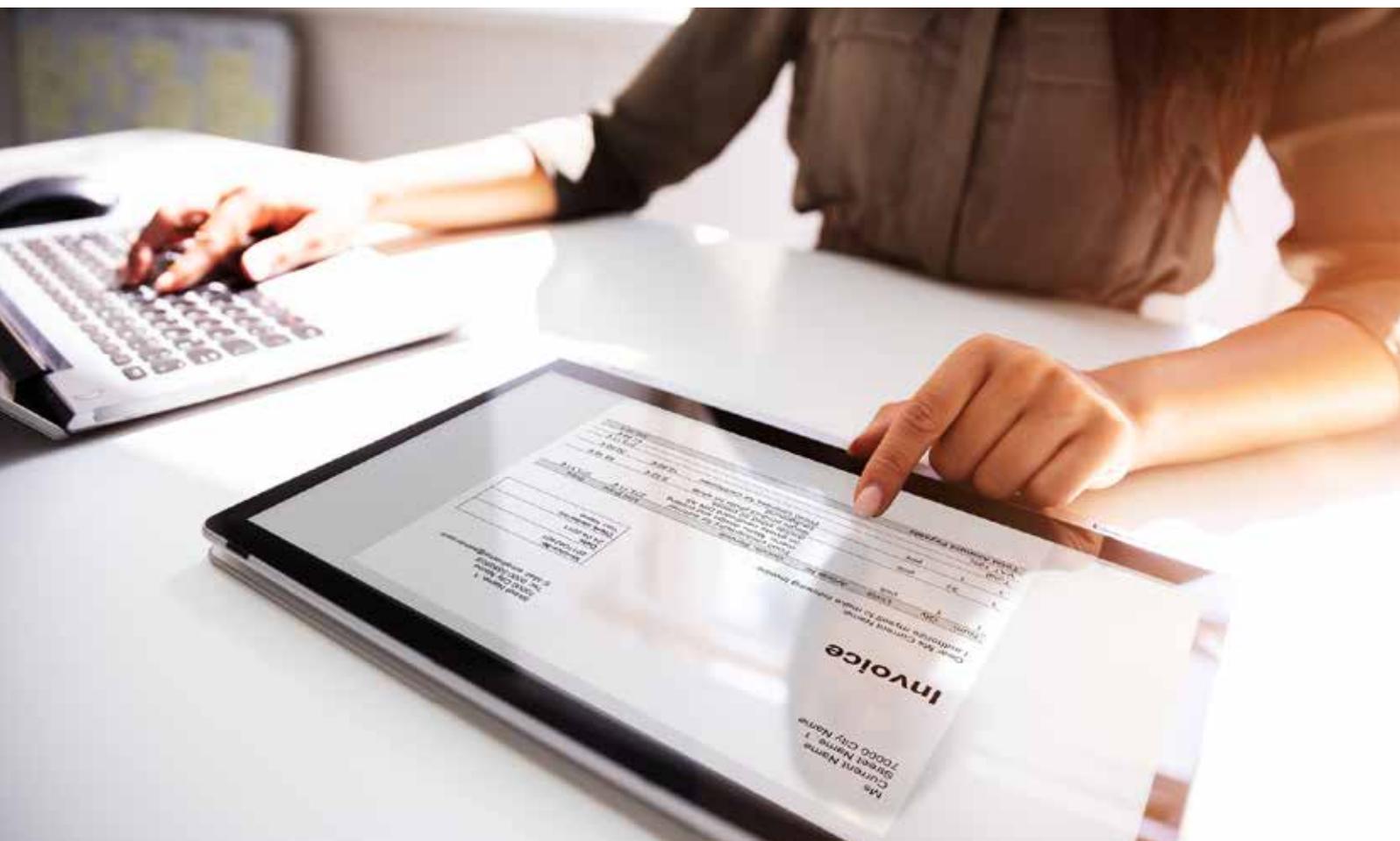
STARTING JANUARY 1st, 2022

- ▶ The cross-border transactions report “*Esterometro*” is no longer mandatory.
- ▶ Manual integration of community invoices and the preparation of self-invoices for non-EU subjects no longer needed.
- ▶ Automation of bookkeeping.
- ▶ Automatic and electronic storage of foreign and intra-community invoices instead of storage of hard copies. In other words, it will allow the substitute conservation of the aforementioned invoices which can be managed with the same mean the taxpayer already applied for the e-invoices.

Art. 1, paragraph 1103, of Law 178/2020 (reformulating Article 1, paragraph 3-bis of Legislative Decree no. 127 of 5 August 2015) has introduced some important changes regarding the communication of cross-border transactions (here hereinafter “*Esterometro*”) which will apply to transactions carried out from January 1st, 2022.

The changes to the electronic invoicing path, mandatory from January 1st, 2022, allow the “management” of document flows also related to transaction with not resident counterparts trough issuing an e-document using specific “*Tipo Documento*” (Document Type) codes thus avoiding the filling and submission of the *Esterometro*.

In particular, the preparation and submission through the ES (SdI) of these new “*Tipo Documento*” allows not only to be exempted from including the data of these operations in the “*Esterometro*”, but also enabling the VAT subject to skip the ordinary procedure of integration of the invoice issued by the intra-EU supplier or the creation of the self-invoice in case of services provided by non-EU suppliers.

The Customer can send us a copy of the individual foreign or intra-community invoices or a copy of the registers of the purchase/sales invoices (once the accounting records have been completed), along with the supplier/customers data, and we will then proceed to send the individual documents.

No changes for accounting records

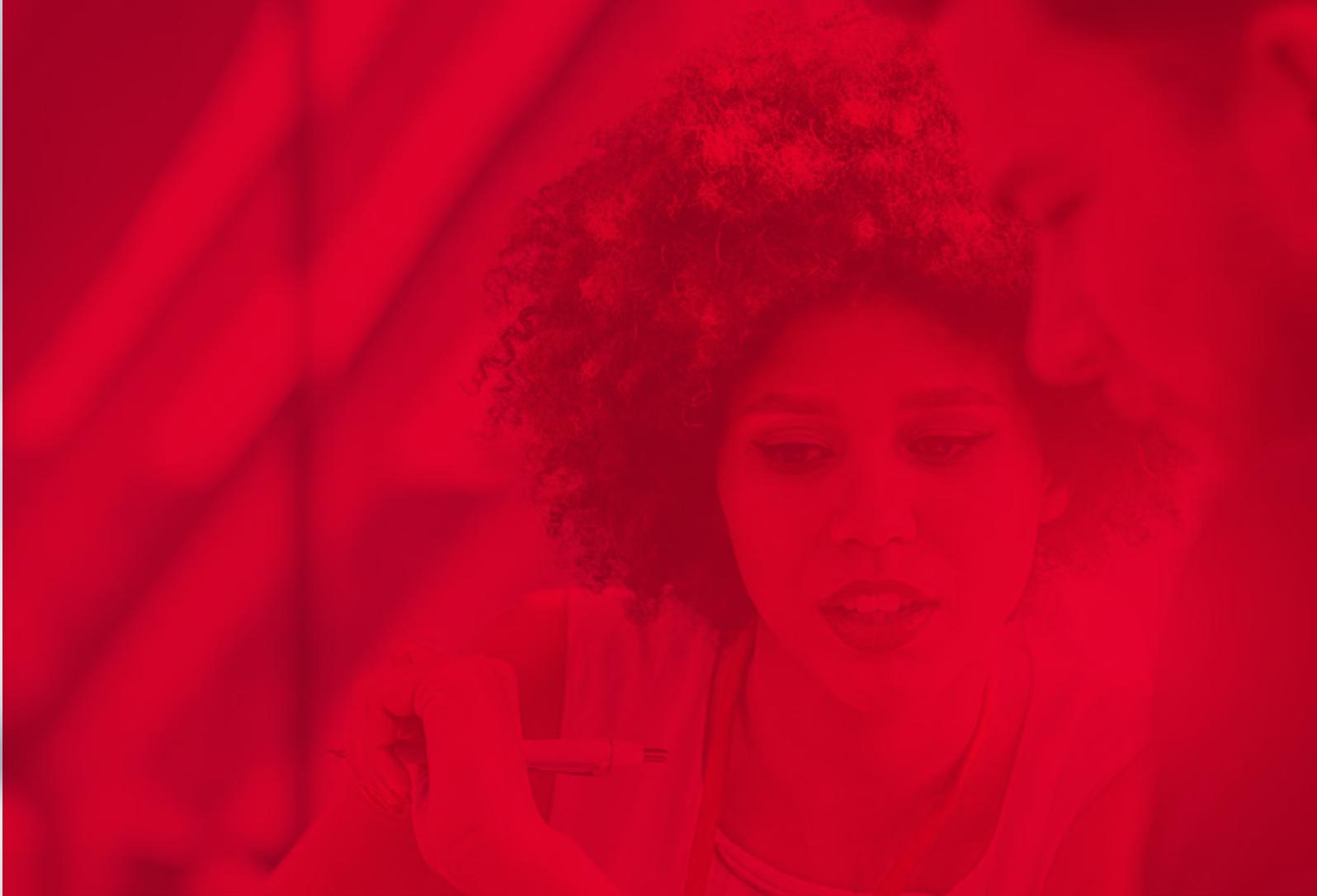
The customer can keep the current accounting bookkeeping of intra and extra-community invoices as is without applying any change.

Digital signature

BDO can apply a digitally signature to the file produced with the signature certificate on behalf of the Customer before submitting it to the Revenue Agency. Alternatively, the Customer can apply his own digital signature directly on the XML documents produced before sending.
